

# GOVERNMENT VERIFIED IDENTITY DOCUMENT

## FORM INSTRUCTIONS

Last revised: 7/24/17

### 1. **PURPOSE:**

- 1.1. To provide a form for use in providing legally admissible evidence of identity required when completing usually government or financial institution forms and which satisfies the following purposes:
  - 1.1.1. Has a photo of you.
  - 1.1.2. Is issued by the government.
  - 1.1.3. Is provided for those who are not able to provide sufficient photo ID to authenticate their identity to the passport acceptance agent. This could be because they do not have a state driver's license or their old expired passport connects them to government issued identifying numbers that they now know are not theirs and are inaccurate.
  - 1.1.4. Does not connect you to any government franchise, license, or benefit.
  - 1.1.5. Is not associated with any government issued identifying number such as Social Security Number (SSN) or Taxpayer Identification Number (TIN).
  - 1.1.6. Acts as a substitute for state-issued photo ID that connects you to licensed activity or franchises applicable only to federal territory.
- 1.2. This form is government issued because it is notarized by a public officer of the government. All notaries public are "public officers" and therefore anything notarized by them which also contains a photo becomes "Government ID".

*Chapter 1*

*Introduction*

*§1.1 Generally*

**A notary public (sometimes called a notary) is a public official appointed under authority of law** with power, among other things, to administer oaths, certify affidavits, take acknowledgments, take depositions, perpetuate testimony, and protect negotiable instruments. Notaries are not appointed under federal law; they are appointed under the authority of the various states, districts, territories, as in the case of the Virgin Islands, and the commonwealth, in the case of Puerto Rico. The statutes, which define the powers and duties of a notary public, frequently grant the notary the authority to do all acts justified by commercial usage and the "law merchant".

- 1.3. Readers are cautioned that all the following forms of ID connection you to government franchises, licenses, or identifying numbers and therefore should be avoided when providing proof of identity in connection with any of your government relationships or commercial activities.
  - 1.3.1. Social Security Card
  - 1.3.2. USA passport applied for using a Social Security Number.
  - 1.3.3. State-issued driver's licenses or State Resident ID.

Almost all the above forms of ID make either requesting or supplying an SSN or TIN and being a statutory but not Constitutional "U.S. citizen" (pursuant to 8 U.S.C. §1401) domiciled on federal territory MANDATORY. If you aren't eligible for Social Security, then you also aren't eligible for any of the above forms of ID and you will contradict yourself by applying for them or keeping them if you either never applied for Social Security or quit it.

### 2. **REASON WHY THIS DOCUMENT IS NECESSARY:**

- 2.1. The exhaustive research on the SEDM website establishes that all government issued ID, including State Driver's Licenses, State Resident Cards, Social Security Cards, and USA Passports applied for with SSNs or TINs are used to:
  - 2.1.1. Cause you to waive sovereign immunity pursuant to 28 U.S.C. §1605(a)(2).
  - 2.1.2. Misrepresent your citizenship status and domicile to be located on federal territory not protected by the Constitution.
  - 2.1.3. Connect you to government franchises that are only available to those in government "employment", office, or domiciled on federal territory not protected by the Constitution.

- 2.3. Those who are carefully following the curricula and procedures on this website realize that it is extremely important not to connect themselves to government franchises or the government issued identifying numbers that are associated with them, including SSNs and TINs. This form makes it possible to apply for a basic government service that is NOT a franchise.

**3. PROCEDURE FOR USE:**

- 3.1. Print out TWO copies of the form. Both will become originals
  - 3.1.1. One will be submitted with your government application or financial account application.
  - 3.1.2. One will be kept for your records.
- 3.2. Obtain TWO photos of yourself.
  - 3.2.1. Go to a UPS Store, Postal Annex, etc. that does passport photos.
  - 3.2.2. Take an electronic picture of yourself with your digital camera and print it out.
- 3.3. DO NOT fill out the form until you are in the presence of the notary public personally.
- 3.4. Permanently glue the picture to the box provided on the two copies of the form.
- 3.5. Find a notary public.
- 3.6. Have the notary public complete and notarize both copies of the form.
- 3.7. Attach one original to the government application or financial account application and keep the other original for your records. You may also need it later for other purposes.
- 3.8. We always want to improve the quality of the information we offer on our website and feedback helps with that improvement. ## **GOVERNMENT VERIFIED IDENTITY DOCUMENT**

I, \_\_\_\_\_ (full legal birthname) swear/affirm under penalty of perjury under the laws of the State of \_\_\_\_\_, the following facts:

1. All identification documents and images provided or described herein to verify this notarized document and statement are true and correct and refer to me personally.
2. For instances of the use of this document as identification, I am an exclusively private human being NOT representing any office or exercising any agency on behalf of any government, such as “citizen”, “resident”, or “person” (under civil statutory law), “taxpayer” (under tax code), “driver” (under vehicle code), “spouse” (under family code) etc.

6. I am a “citizen” under the United States of America Constitution by virtue of birth or naturalization in the United States of America.
7. I am not any of the following and do not consent to act as any of the following capacities:
  - 7.1. A “person”, “subject”, “citizen”, “resident” or “inhabitant”, or any other status under any civil law enactment of any government. All “persons” are aliens under the tax code per 26 C.F.R. §1.1441-1(c)(3). Statutory “citizens of the United States\*\*” (federal territory) under 8 U.S.C. §1401 and 8 U.S.C. §1101(a)(22)(A) only become “individuals” and “persons” when abroad under 26 U.S.C. §911(d)(1) and I am not abroad and not a statutory “citizen”.
  - 7.2. A statutory “citizen of the United States\*\*” (federal territory) under 8 U.S.C. §1101(a)(22)(A).
  - 7.3. A statutory “national and citizen of the United States at birth” as defined in 8 U.S.C. §1401. These parties are born in territories such as Puerto Rico.
8. For the purposes of this document, “United States” means (is limited to) ONLY federal territory and excludes states of the Union.
9. Only for the purpose of the creation of this document do I submit to the perjury statutes and allow myself to be regarded as a public officer subject to government enforcement; for every other purpose I am a private nonresident. Under the U.S. Supreme Court State Action Doctrine, everyone who is subject to government enforcement or compulsion is acting as an agent of the government. The reader will note that BOTH myself as a compelled agent of the state for perjury purposes AND the notary witnessing this document are regarded as agents of the state and therefore government actors.<sup>1</sup> Therefore, this document qualifies as “government ID” because it is issued by someone acting as an agent of the government.
10. This document is not authorized for any commercial use that would financially benefit any government. Government recipients of this document benefitting commercially by its use hereby implicitly consent to return and refund all such benefits in full to me personally. I own myself and the fruits of any and all uses of my identity for commercial use. Otherwise, recipient and affiant hereby acknowledge that identity theft has occurred.

If the recipient of this form believes that the information provided herein is insufficient proof of identity for the purpose of the transaction to which this form relates, they are demanded to promptly submit the following proof that it is legally insufficient signed under penalty of perjury with the full legal birthname of the party requesting. The statute(s), regulation(s), and case law stating that this document alone is insufficient proof of identity and mandating that MORE than provided here is required. We are a society of laws and not men. There is no room for the exercise of "arbitrary power" in a free republic. "If additional information is requested by recipient, then applicable privacy statutes and regulations for the recipient require them to disclose the following information hereby demanded:

1. A statement of TO WHOM outside your agency the additional information requested beyond this submission will be shared with and the uses to which it will be put AFTER the requested service or product is provided.
2. A statement of whether the additional information requested beyond the application included with this submission will be entered into any information system that is accessible to anyone outside your agency, and a detailed list of all such information systems.
3. A statement of whether the information provided will be used for criminal law enforcement beyond that required to ensure the accuracy of the application provided with this document. This is a requirement of the Miranda Doctrine.
4. A statement of whether a Social Security Number will be extracted from the additional information to be entered into any records pertaining to me. I do not wish this to happen and it is ILLEGAL for me to request or use a Social Security Number according to the following:
